4. FIRST AID MEASURES

Description of necessary measures

Inhalation: If inhaled, immediately remove the affected person to fresh air.
Skin contact: First aid measures not required. Cosmetic product and therefore not necessary.
Eye contact: Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation develops.
Ingestion: Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After inhalation: Breathing high vapor concentrations may produce anesthetic effects, nausea, dizziness, headache. After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.

Indication of any immediate medical attention and special treatment needed

5. FIRE FIGHTING MEASURES

Special protective equipment and precautions for fire-fighters

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up
